1. The consent order issued vide Board proceeding dated 30.04.2021 (cited under reference third) under both Acts are cancelled and recorded

2. The industry shall operate and maintain the Combined STP efficiently and continuously to achieve

the standards prescribed by the Board.

3. The industry shall utilize the treated sewage completely on land for Gardening after meeting standards prescribed by the Board.

4. The industry shall operate and maintain the ETP efficiently and continuously so as to bring the quality of the treated effluent to satisfy the standards prescribed by the Board.

5. The industry shall maintain and calibrate regularly the online Continuous effluent quality monitoring system for parameters pH, TSS, & Temperature so as to transmit quality data to Care Air Centre,

TNPCB without interruption.

6. The industry shall not use 'use and throwaway plastics' such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises. Instead it shall encourage use of eco-friendly alternative such as banana leaf, areca nut palm plate, stainless steel, glass, porcelain plates/cups, cloth bag, Jute bag etc.,

7. This consent order does not absolve from obtaining necessary permission / clearance from other

Authority or under other Statute as applicable.
