### Special Additional Conditions:

The unit shall install retrofit emission control device, with atleast 70% Particulate matter reduction efficiency on all DG sets with rated capacity more than 125 KVA installed within the industrial premises before 30.06.2020 or otherwise the unit should be shifting to gas based generators by employing new gas based generators. The retrofit emission control device should be tested from one of the five laboratories recognised by CPCB.

### Additional Conditions:

1. The unit shall operate and maintain the APC measures efficiently and continuously so as to satisfy the AAQ/Emission standards prescribed by the Board.
2. The unit shall adhere to the Ambient Noise Level standards prescribed by the Board
3. The unit shall operate and the water sprinklers effectively to suppress the dust generated during mining, crushing and vehicle movements.
4. The haul roads in the mines shall be adequately water sprayed
5. The unit shall not use 'use and throwaway plastics' such as plastic sheets used for food wrapping, spreading on dining table etc., plastic plates, plastic coated tea cups, plastic tumbler, water pouches and packets, plastic straw, plastic carry bag and plastic flags irrespective of thickness, within the industry premises.
