**Additional Conditions:**

1. The unit shall treat and dispose the sewage generated from the unit through septic tank followed by soak pit.
2. The unit shall continue to develop more green belt in and around the premises. The Thick green belt shall be with native species and developed in the 50 m safety distance in the land area in the periphery.
3. Peripheral plantations shall be raised as wind belts to minimize the dry tailings being air-borne and to prevent the soil erosion.
4. Garland drains provided around the open cast excavation area, stacking, loading area and periphery of waste dumps shall be maintained so as to collect and discharge the rush of water during heavy rain. The water collected in the garland drain shall flow towards the settling tank.
5. The unit shall collect the rain water and seepage in the collection sump proposed to be provided and the same shall be utilized for irrigation.
6. Wherever practicable, the mine water shall be utilized for irrigation and to the plantation raised to stabilize the mine waste dumps.
7. The unit shall comply with the conditions mentioned in the EC issued by MoEF, GOI New Delhi.
8. The unit shall comply with Mines and Minerals (Development and Regulation) Amendment Act 2015.
