- I. The SEIAA, AP had issued Environmental Clearance (EC) vide reference 1<sup>st</sup> cited for M/s. Chettinad Cement Corporation Pvt. Ltd. (formerly M/s. Anjani Portland Cements Ltd.), at Survey Nos. are 1,2,3,9,10,11, 12,13 & 14 in Gaithulapalem Village, Sy. Nos. 181, 182, 183 & 184 in Tallapalem Village & Sy. No. 68 in Narasapuram Village, Kasimkota (M), Visakhapatnam District, A.P.
- II. Now, the Project proponent vide reference 2<sup>nd</sup> cited requested to issue corrigendum to EC issued vide order dated 27.11.2018, making the following corrections in the EC:

Accordingly, the request of the proponent was examined by the State level Expert Appraisal Committee (SEAC) in its meetings held on 25.02.2019. The representative of the project proponent and their consultant M/s.Pioneer Labs and Consultants have attended the meeting. The committee noted that the Environmental Clearance was issued on 27.11.2018 for the proposed Standalone Cement Grinding unit: Cement - 2.0 MTPA (Million TPA) (Ordinary Portland Cement (OPC)/ Portland Pozzolana Cement (PPC)/ Portland Slag Cement (PSC) duly stipulating the standard conditions and other conditions. The project proponent requested for the corrigendum in the conditions of EC order. The committee recommended for issue of corrigendum in the EC order dated 27.11.2018 as requested by the project proponent vide their letter dated 28.01.2019 as in Special condition No.1: "The transportation of raw material and finished product through Rail / Road transport"; Special condition No.2: shall be deleted; and Specific Condition Point No.(i), Under (b) Water Pollution: "The source of water is bore well. Total water requirement is 450 KLD. Out of that 25.0 KLD is used for dust suppression, 304 KLD is used for Cooling; 110 KLD is used for development of Greenbelt and 11 KLD is used for domestic purpose. The domestic wastewater of 8.8 KLD is to be disposed into septic tank followed by soak pit".



- III. The State Level Environment Impact Assessment Authority (SEIAA), in its meeting held on 13.03.2019 examined the proposal and recommendation of SEAC and decided to issue corrigendum to Environmental Clearance (EC) issued vide order dated 27.11.2018.
- IV. In view of the above, The SEIAA, A.P hereby accords corrigendum to the Environmental Clearance (EC) issued vide letter dated 27.11.2018 as follows:
  - a) The special condition No.1 shall be read as "The transportation of raw material and finished product through Rail / Road transport";
  - b) The special condition No.2: shall be deleted.
  - c) The specific Condition Point No.(i), Under (b) Water Pollution shall be read as "The source of water is bore well. Total water requirement is 450 KLD. Out of that 25.0 KLD is used for dust suppression, 304 KLD is used for Cooling; 110 KLD is used for development of Greenbelt and 11 KLD is used for domestic purpose. The domestic wastewater of 8.8 KLD is to be disposed into septic tank followed by soak pit".
- V. All other information mentioned and conditions stipulated in the Environmental Clearance (EC) issued vide reference 1<sup>st</sup> cited remains the same.
