The Company’s efforts in the past for constructing housing facilities for economically weaker sections, construction at schools, hospitals, sanitation programmes in rural areas, skill development programmes for the rural youth, free medical camps etc., have been widely appreciated. The Companies Act, 2013 in effect gives an impetus to the efforts of the Company in this direction; by allowing it to set up a formal framework for such activities, and allotting an exclusive budget for the fulfilment of corporate social responsibilities.
- 1.2 This Corporate Social Responsibility (“CSR”) Policy document sets out the framework under which the Company should carry out its CSR activities.

### **2. DEFINITIONS**

- 2.1 In this policy, unless the context otherwise requires the following expressions shall have the meanings ascribed against them:
- (a) “Act” means the Companies Act, 2013.
  - (b) Administrative Overheads means the expenses incurred by the company for ‘general management and administration’ of Corporate Social Responsibility functions in the company but shall not include the expenses directly incurred for the designing, implementation, monitoring and evaluation of a particular Corporate Social Responsibility project or programme.
  - (c) “Board” means the Board of Directors of the Company.
  - (d) “Corporate Social Responsibility (CSR)” means activities undertaken by the Company pursuant to its CSR obligations and shall not include the expenses as laid down in the Act and Rules as amended from time to time.

- (e) “CSR Committee” means the CSR Committee of the Company constituted in accordance with Section 135 of the Act.
- (f) “CSR Policy” or Policy shall means a statement containing the approach and direction given by the Board of a company, taking into account the recommendations of its CSR Committee, and includes guiding principles for selection, implementation and monitoring of activities as well as formulation of the annual action plan’
- (g) “CSR Programme” shall have the meaning specified under Paragraph 7.
- (h) “Rules” shall mean the Companies (Corporate Social Responsibility Policy) Rules, 2014 as amended from time to time.
- (i) “Ongoing Project” means a multi-year project undertaken by a Company in fulfilment of its CSR obligation having timelines not exceeding three years excluding the financial year in which it was commenced, and shall include such project that was initially not approved as a multi-year project but whose duration has been extended beyond one year by the board based on reasonable justification.
- (j) “Net Profit” means the net profit ascribed and calculated under the Companies Act, 2013 and CSR Rules duly amended from time to time.
- (k) “Organisations” means Company established under Section 8 of the Act or a registered trust or a registered society or registered under Section 12A and 80G of Income Tax Act, or established by the Central Government or State Government, or under an Act of Parliament or a State legislature respectively, and having an established tract record of atleast three years is undertaking similar activities.

2.2 Words and expressions used in this Policy, but not defined here shall have the same meaning as specified under the Companies Act, 2013 and Rules thereunder.

### **3. OBJECTIVES**

The CSR Policy seeks to carry out the following objectives:

- (a) To specify the broad scope of CSR activities of the Company;
- (b) To stipulate the framework under which the CSR Programme of the Company will be formulated and executed;
- (c) To establish systems and processes for monitoring implementation of the CSR Programme;
- (d) To ensure compliance with the provisions of Section 135 of the Act and the Rules made thereunder, and fulfil the provisions of law in letter and spirit.

#### **4. CSR COMMITTEE COMPOSITION**

4.1 A Committee of Board of Directors has been formed in pursuance of Section 135 of the Companies Act, 2013. CSR Committee comprises of three Directors as members.

#### **5. RESPONSIBILITIES OF CSR COMMITTEE**

5.1 The Responsibilities of CSR Committee includes-

- (a) Formulating and recommending to the Board of Directors an annual action plan which shall include –
  - (i) the list of CSR Projects or programmes that are approved to be undertaken in areas or subjects specified in Schedule VII of the Act;
  - (ii) the manner of execution of such projects or programmes as specified in sub-rule (1) of rule 4;
  - (iii) the modalities of utilisation of funds and implementation schedules for the project or programmes;
  - (iv) monitoring and reporting mechanism for the projects or programmes; and
  - (v) details of need and impact assessment, if any, for the projects undertaken by the company.

- (b) Recommending the amount of expenditures for CSR activities. Provided that such plans may be altered at any time during the financial year, as per the recommendations of the CSR committee, based on the reasonable justification to that effect.

## **6. SCOPE OF CSR ACTIVITIES**

The Company may carry out any project, program or activity in the areas specified under Schedule VII of the Act as on date, or as may be specified from time to time.

## **7. ANNUAL CSR PROGRAMME**

- 7.1 The CSR Committee shall prepare an indicative programme of CSR Projects/activities ("CSR Programme") to be carried or by the Company during each financial year. The CSR Programme may inter alia specify the projects or programs which the company plans to undertake, modalities for execution, implementation schedule, monitoring and reporting systems etc., as required, with respect to the CSR projects to be implemented by the Company.
- 7.2 The CSR Programme shall be approved by the Board of Directors of the Company. Such Programme shall upon approval be deemed to constitute a part and parcel of the CSR Policy of the Company.
- 7.3 The Board of Directors may, in consultation with the CSR Committee approve any CSR expenditure or expend the CSR budget on any project/activity, which is part of the CSR Programme on case to case basis.

## **8. BUDGET FOR CSR ACTIVITIES**

- 8.1 The Company shall in each financial year, allocate funds amounting atleast 2% of the average net profits of the company made during the three immediately preceding financial years, for purposes of carrying out the programs and activities under the CSR Policy. Provided that the minimum limits aforesaid would not apply, if the Company is not required to comply with the provisions of Section 135 of the Act/Rules thereunder for any reason.

- 8.2 Surplus, if any, arising from CSR Projects or Programmes or activities shall not form part of the business profits of the Company, but shall be added to the CSR budget of the Company.

## **9. IMPLEMENTATION OF CSR POLICY**

- 9.1 The Company may undertake its CSR activities either by itself, or through a registered trust or a registered society or a Section 8 company established by the company itself as specified under the Rules.
- 9.2 The Company may collaborate with other companies for undertaking projects or programmes or CSR activities in such a manner that the CSR Committee of the respective companies are in a position to report separately on such projects or programmes in accordance with the Rules.

## **10. REVIEW AND REPORTING**

- 10.1 The CSR Committee shall set in place a transparent monitoring mechanism for implementation of the CSR projects or programs or activities undertaken by the Company.
- 10.2 The CSR Committee will review the activities carried out under the CSR Policy and prepare a progress report on periodical basis. The report shall be placed before the Board of the Directors of the Company for their review and information.
- 10.3 The report of the CSR activities of the Company shall be included in the Board's Report under Section 134 of the Act.

## **11. PROJECTS/ANNUAL ACTION PLAN**

All CSR initiatives/projects/programs/activities shall continue to fall under the purview of Schedule VII of the Act as attached to this policy in Annexure-I as amended from time to time. Further, CSR Committee will prepare Annual Action Plan for each financial year with respect to the project identification based in the area as per Schedule VII for which the company shall spend the CSR funds. The Annual Action Plan shall be recommended to the Board of Directors for approval in its meeting.

The composition of the CSR committee and CSR Policy and Projects approved by the Board shall be disclosed on their website for public access.

## **12. AMENDMENTS TO CSR POLICY**

The Board may alter all or any of the provisions of the CSR Policy in accordance with the extant law in force in India and recommend the same to the Board for its approval.

5. Protection of national heritage, art and culture including restoration of buildings and sites of historical importance and works of art; setting up public libraries; promotion and development of traditional art and handicrafts;
6. Measures for the benefit of armed forces veterans, war widows and their dependents, Central Armed Police Forces (CAPF) and Central Para Military Forces (CPMF) veterans, and their dependents including widows;
7. Training to promote rural sports, nationally recognised sports, paralympic sports and olympic sports;
8. Contribution to the Prime Minister's National Relief Fund or Prime Minister's Citizen Assistance and Relief in Emergency Situations Fund (PM CARES Fund) or any other fund set up by the central govt. for socio economic development and relief and welfare of the schedule caste, tribes, other backward classes, minorities and women;
9. (a) Contribution to incubators or research and development projects in the field of science, technology, engineering and medicine, funded by the Central Government or State Government or Public Sector Undertaking or any agency of the Central Government or State Government; and  
  
(b) Contributions to public funded Universities; Indian Institute of Technology (IITs); National Laboratories and autonomous bodies established under Department of Atomic Energy (DAE); Department of Biotechnology (DBT); Department of Science and Technology (DST); Department of Pharmaceuticals; Ministry of Ayurveda, Yoga and

Naturopathy, Unani, Siddha and Homoeopathy (AYUSH); Ministry of Electronics and Information Technology and other bodies, namely Defense Research and Development Organisation (DRDO); Indian Council of Agricultural Research (ICAR); Indian Council of Medical Research (ICMR) and Council of Scientific and Industrial Research (CSIR), engaged in conducting research in science, technology, engineering and medicine aimed at promoting Sustainable Development Goals (SDGs);
